SOCIETY INCORPORATION - On April 12, 1978, the Board of Directors adopted resolutions making the Society a corporation under the laws of the State of New Jersey. This was done primarily to limit membership liability. Nonsubstantial changes have been made in the Constitution and Bylaws to conform with State nomenclature. The Advisory Board is no longer limited to five persons: the president may appoint as many as he (she) find appropriate.

HISTORIC STRUCTURES SURVEY - Time is marching on for the historic structures survey--concentration is shifting to the Wyoming area of Millburn.

Much work still remains to be completed on the Short Hills area, in particular the Hartshorn houses--so-called because they were designed as part of Stewart Hartshorn's "ideal village."

The Wyoming Land and Development Company originally built what are loosely termed (wrongly, I think) "original Wyoming houses." These are distinguished by a square tower on the front or side of the house and are distinctive in the area today.

As you drive along Glen Ave. and approach the junction of Glen Avenue and Sagamore Rd., look straight ahead. Through the foliage and tasteful restoration is one of the remaining Wyoming houses. This house also sports an interesting contemporary sculpture.

Another of this group of houses is dark brown with light green trim and can be found on Chestnut St.

The original Wyoming School is a charming residence on Cypress St.

Riding or (better for your health!) walking on Sagamore Rd. provides an interesting and varied architectural experience, with Victorian and contemporary houses existing comfortably side by side.

Treat yourself to a walk in one of Millburn's most varied and interesting areas at this most beautiful time of the year.

ARCHITECTURAL WALKING TOUR - The architectural walking tour this fall will be held at 2 pm, Sunday, October 22nd (with the 29th as a rain date). The tour will start in front of the Wyoming Presbyterian Church, located on Wyoming Ave. between Linden and Cedar Streets, and it is planned to cover an area of three blocks bound by Wyoming, Cedar, Sagamore and Glen. The walk is about one mile and the tour should last about two hours.

It should be of unusual interest due to the additional information recently obtained through the Historic Structures Survey. From the street about 35 houses will be described by Sandy Brown of Summit, leader of last year's successful tour in Short Hills. Mrs. Brown is a well known writer and lecturer on architectural heritage.

The public is invited and there is no charge.

MARIAN K. MEISNER CITATION - Marian K. Meisner was cited by both the Township and the Society at the May annual meeting for her extensive research and writing on local history. Her book, entitled Millburn, was published in 1957 in celebration of the town's centennial, and it, together with bibliographic notes, is available at the Library.

Dan Hussey, on behalf of the Society, said that "Mrs. Meisner's history owes its greatness to the charm of its style and to the collection of delightful stories through which her historical recital digresses and progresses." Mayor Alexander B. Lyon, Jr., presented Mrs. Meisner with a framed citation and expressed the town's appreciation for her interest in our history, which has "increased the pride our citizens have in the township of Millburn."

The Society will donate a special collection of books to the Library in recognition of Mrs. Meisner's contributions to Millburn history. Titles in the collection will be published in the next edition of the Thistle.

HISTORICAL SOCIETY HISTORY PRIZE - The Millburn-Short Hills Historical Society offers two prizes in history at Millburn High School. One is for the best project by a student in the history of Millburn Township, and the other is for general excellence in the study of history.

This year the prize for general excellence was split between Alkey Glimis and William Fisher, two graduating Seniors. Presented by Mrs. Juli Towell, liaison between the High School and the Historical Society, the prize consisted of books, the American Heritage Dictionary and the Elements of Style by William Strunk and E. They have welcomed us into their classrooms and made every effort to further our good relationship. CONTRATULATIONS to Fran Land, our founding president, on her appointment to the Millburn Township Planning Board! Judging from the enthusiasm and knowledge that she brought to her job with the Millburn-Short Hills Historical Society, we think Fran will make a fine contribution to the Planning Board.

SURVEY REPORT - Climbing laboriously up its mountain of accumulated information, the Historic Structures Survey Committee is struggling to shape its data into a meaningful whole.

Our project continues to make a history of its own. New Jersey recently gave us a time extension on our grant to February 1, 1979. As with many projects of this magnitude, everything seems to take longer and cost more than we originally estimated.

We have explained in previous issues of the Thistle that the survey is unique in its use of volunteers, both as managers and workers, and the computerization of data collected.

Status - always fluid! We are still surveying sites of historic architectural interest, but most of the ground has been covered. The committee will soon begin to review the data with knowledgeable town residents--people familiar with the neighborhoods in question--to check on facts or sites.

We will then begin to analyze the data and begin to define historic district lines to decide which areas are to be included in the submission for nomination to the State and National Register of Historic Places.

Fran Land has made an early start on writing the report on the town that will accompany the mountain of information mentioned at the top of this article. With Fran, there is always a good reason for what she does--and this is no exception. She is looking for gaps in the collected information.

That there will be gaps we have no doubt. We will be needing volunteers to undertake specific short term assignments to fill in these holes in our knowledge about Millburn. If you would like to help, please call project coordinator, Ann Klemme at 376-3970.

ORAL HISTORY - Over the summer, Oral History has begun to put its records in good order so that these precious remembrances of times and people past will be adequately preserved, and is ready to commence a new season of interviews. Volunteers are needed in the following categories:

A) One or two verbatim transcribers; typists who will be able to transcribe word for word from the taped interviews for those tapes the Society deems important enough to preserve in print in this manner.

B) Two or three summary transcribers; typists able to transcribe from a tape the flavor and important or interesting facts and description of taped interviews the Society feels would be best preserved in this manner.

C) Dispatcher; an appointment director who will make assignments and be responsible for seeing that they are completed.

D) Interviewers; requirements are a tape recorder, interest in the people and development of Millburn-Short Hills, time to give, and a willingness to come on October 19, at 9:30 am at Gero Park to take part in a workshop to share talents and experiences and sharpen interview skills. All former interviewers are encouraged (begged) to come, and all interested new volunteers are assured of a hearty welcome. Bring your recorder, microphone and blank tape. NEW JERSEY HISTORICAL SOCIETY - The New Jersey Historical Society is an exciting place these days. It has a new director, Dr. Clifford Lord, a new commitment to bring the history of New Jersey to the residents of the State, and a new research program into the history of industry and the contributions of ethnic groups.

The collections of the Historical Society provide a superb basis for new ventures. The library's manuscript holdings include an original copy of the charter granted by Charles II to Lord Berkeley and Sir James Carteret. The newspaper collection ranges from before the Revolution up through the 1930's. Pictures, silver and china as well as household utensils all help researchers to learn a great deal about the people who lived in New Jersey. These collections are used to form exhibits which illustrate various aspects of our history. The building is open from 10:00 am to 4:15 pm, Tuesday through Saturday.
